The sale of the specified residential properties will be divided into 3 groups (namely Group A1, Group A2 and Group B). The persons or companies interest in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual registrants can only participate in any **ONE** group. Company registrants can only participate in **Group B**. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

## **Part (II) : Registration**

1. The registrant(s) must submit the following **personally** to 19/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Sales Office”) at or before 5 p.m. on the day before the First Date of the Sale (“the Deadline of Submission”):-

- i) All Group A1 Registrants must **personally attend** 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Designated Venue”) from 2:30 p.m. to 3 p.m. (“Group A1 Attendance Registration Period”) on the First Date of Sale. Group A1 Registrant(s) who arrives at the Designated Venue at any time after the Group A1 Attendance Registration Period shall not be eligible to participate in the balloting.

- iii) If the Group A1 Registrant(s) who has selected two (2) to six (6) specified residential properties according to the ballot result sequence on the First Date of the Sale, but for whatever reason is/are unable or refuse to sign Preliminary Agreement for Sale and Purchase of any one of the selected specified residential properties, it will be deemed that the said Group A1 Registrant(s) has given up the right to select and purchase the specified residential properties in Group A1 Unit Selection. In such event, such Group A1 Registrant(s) will not be eligible to select any of the specified residential properties in Group A1 Unit Selection on the First Date of the Sale.

**b) Group A2 Unit Selection**
