Part (I) : Abstract

第(I)部分：摘要

The sale of the specified residential properties will be divided into 2 groups (namely Group A and Group B). The persons or companies interested in purchasing any of the specified residential properties are referred to below as “the registrant(s)”. Individual registrants can only participate in any **ONE** group. Company registrants can only participate in **Group B**. Duplicated registration among different Groups will not be accepted and his/her/their registration in later group(s) will lapse automatically.

Each individual registrant(s) (whether in his/her own name or in joint names with any other party(ies)) can submit **either only ONE (1) Registration of Intent Form A or a maximum of TWO (2) Registration of Intent Form B**. More than the allowed Registration(s) of Intent (whether in his/her own name or in joint names with other parties) submitted from the same registrant will not be accepted.

A registrant shall not include both company(ies) and individual(s).

6. The registrants will be divided into two (2) groups for balloting to determine the order of priority of selection of the specified residential properties and two (2) rounds to select and purchase the specified residential properties.

A) Procedures for Group A

a) Group A Balloting

- i) All Group A Registrants must **personally attend** 10/F, Tower 2, The Gateway, Harbour City, Tsim Sha Tsui, Kowloon, Hong Kong (“the Designated Venue”) from 3:00 p.m. to 3:30 p.m. (“Group A Attendance Registration Period”) on the First Date of Sale. Group A Registrant(s) who arrives at the Designated Venue at any time after the Group A Attendance Registration Period shall not be eligible to participate in the balloting.

After verification and confirmation of identity by the Vendor, balloting will be conducted to determine the order of priority in which the Group A Registrant may select the specified residential properties. For the purpose of the balloting, all attended Group A Registrants per every valid Registration of Intent shall be allotted one lot.

- i) On the First Date of Sale, the Group A Registrant(s) must select and purchase **at least two (2) and at most three (3)** specified residential properties and **any one (1) of the units must be three-bedroom or above** of the specified residential properties in the order of priority according to the ballot results.

- iii) If the Group A Registrant(s) who has selected two (2) to three (3) specified residential properties according to the ballot result sequence on the First Date of the Sale, but for whatever reason is/are according to the ballot result sequence on the First Date of the Sale, but for whatever reason is/are

unable or refuse to sign Preliminary Agreement for Sale and Purchase of any one of the selected specified residential properties, it will be deemed that the said Group A Registrant(s) has given up the right to select and purchase the specified residential properties in Group A Unit Selection. In such event, such Group A Registrant(s) will not be eligible to select any of the specified residential properties in Group A Unit Selection on the First Date of the Sale.

The ballot results, including “registration number”, “ballot result sequence” and “the check-in timeslot for registrants” shall be posted at the Sales Office at or before 8:00 p.m. on 21 March 2017. The registrant(s) will not be separately notified of the ballot results. The opening hours of the Sales Office on 21 March 2017 are from 11:00 a.m. to 6:00 p.m.

The Group B registrant(s) whose identity(ies) has/have been verified by the Vendor shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot result sequence. The Group B registrant(s) who arrive at the Designated Venue at any time later than “the check-in timeslot for registrants” assigned in the ballot results shall not be eligible to select the specified residential properties in the order of priority according of the ballot results.

Any changes to the time of the Group B Unit Selection will be announced at the Designated Venue. Registrants will not be notified separately of such changes.

Before entering into the Preliminary Agreement for Sale and Purchase in respect of any specified residential property, the registrant(s) may request the Vendor on the spot to add the close family member(s) (which shall mean a spouse, parent, child or sibling of an individual) of the registrant(s) or any person comprising the registrant as joint purchaser(s) provided that the registrant(s) must provide the relevant supporting documents to the satisfaction of the Vendor to prove the relationship(s) and that all the aforesaid persons shall sign the Preliminary Agreement for Sale and Purchase as purchasers personally. The Vendor reserves its absolute discretion to allow or reject the registrant(s) to add any person(s) to sign the Preliminary Agreement for Sale and Purchase.

Details will be announced on the website of the Development and registrants will not be separately notified of the same.
